Pooch At Play agrees to exercise due diligence and reasonable care, and to keep the premises sanitary and properly enclosed. All dogs are handled or cared for by the PCS (Pet Care Specialist) without liability on Pooch At Play's part for loss or damage from disease, theft, fire, death, escape, injury, or harm to person's, other dog(s) or property by said dog, or from other unavoidable causes, due diligence and care having been exercised. Should any dog(s) become ill or seem to be in need of medical attention, Pooch At Play reserves the right to administer aid and/or to use any available veterinarian. All expenses so incurred shall be paid by the owner of said dog in addition to any other applicable fees. Owner agrees to pay the rate for all agreed services in effect, on the date and time the dog is checked into Pooch At Play. Prices are subject to change without notice. Late cancellation fees will be applied for reservations cancelled less than 72 hours of the scheduled reservation. Late pick-up fees will be applied for day care for check-out after 7:30 pm on the day of services in effect at a rate of 0.50 cents per minute for the first 15 minutes and \$1.00 per minute all minutes thereafter. Should my dog(s) not be picked up at the specified time I authorize Pooch At Play to take whatever action Pooch At Play deems necessary for the continuing care of my dog and I will pay all costs and charges thereof. Owner shall remain liable for all daycare bills and other applicable charges accrued in the care and maintenance of the dog listed in this contract. The Owner further agrees to be solely responsible for any and all acts or behavior of said dog while in the care of Pooch At Play. The Owner of the pet agrees to pay any and all attorney fees incurred by Pooch At Play in the collections of any daycare services, training fees, or other charges accrued by the Owner of the dog. Owner shall report any and all incidents of aggression before arriving at Pooch At Play. Valid proof of vaccinations must be present before pet can be dropped off for day care and boarding. Owner also agrees to maintain vaccinations and to keep Pooch At Play up to date on any changes. Pets arriving with fleas/ticks or any other illness will not be accepted.
